hereby undertake to the Board of Architects of Tasmania (the Board) that I will not provide any architectural services in Tasmania while I am registered as a ‘non-practising’ architect on the Tasmanian Register of Architects.

I further undertake to the Board that I have retired from the practice of architecture and or I am not likely to practice architecture in Tasmania within the current registration term;

- I. I will inform the Board within 14 days if I recommence the provision of architectural services;
- II. I will not advertise my architectural services in media, public notices, social media or in any other form of promotional material while registered as a ‘non-practising’ architect; and
- III. I have attached relevant documentation demonstrating that I am retired from the practice of architecture and or that I am not likely to practise as an architect for the current registration term.

## Declaration

I will not provide any of the following services while registered as a ‘non-practising’ architect:

- **Design of buildings**, including
  - Design brief and measured drawings
  - Concept design
  - Design development
  - Development application/planning permit
  - Detailed design/construction documentation
  - Construction Certificate/Complying Development Certificate
  - Opinion of probable cost of works
  - Preparation of drawings, specifications, schedules
  - Coordination of input from specialists and consultants
  - Services provided as a ‘designer’ under the Tasmanian Building Act
- **Planning of buildings**, including
  - Master planning
- **Construction of buildings**, including
  - Preparation of drawings, specifications, schedules
  - Coordination of input from specialists and consultants
  - Design delivery
  - Contractor selection
  - Contract administration (site meetings; assessing variations/time claims/progress claims/defects; issuing progress certificates; determining practical completion)
  - As-built documentation
  - Project management
- **Expert witness services** (relevant to architecture)
- Any other services provided in connection with the design, planning or construction of buildings that are ordinarily provided by architects.
